

Fourth Annual Loving The Skin I'm In

Zoe's Dolls believes that the image of brown girls is important and that their image should be celebrated and herald. It is that belief that led to the creation of Zoe's Dolls Annual Loving The Skin I'm In Creative Expression Contest!

We want to know why being a brown girl is important to you and why you love the skin you are in. Here is your opportunity to have your voice heard! Let the world know that your image matters and that your image is beautiful!

Girls between the ages of 6 and 18 may submit in either the written or short film category. All submissions must be received by April 30, 2018, by 11:59 PM. The first place winner will receive a \$100 cash award, second place will receive a \$75 cash award and the third place winner will receive a \$50 cash award. Winners will be honored at a formal banquet in May.

Written Category Guidelines

- Entries must express why their image is important and why you love the skin you are in!
- Entries in this category may be either an essay, poem, rap, script or a song.
- All entries must be an original piece authored by the person entering.
- Entries must be typed. Font must be 12-points
- Entries must be in English and be no longer than 2 typed pages, one sided.
- You may only enter in one (1) category and may only have one submission.
- Applicants must fill out the online application at www.zoesdolls.com and entries must be submitted to info@zoesdolls.com.
- Entries must be received by April 30, 2018 by 11:59 PM. Any entries received after the deadline will be disqualified.

Short Film Category Guidelines

Entries must express why their image is important and why you love the skin you are in.

- Entries in this category must be a short film or video no longer than 3 minutes long.
- All entries must be original and feature the girl entering the contest.
- Films or videos must list the credits of all involved in making the film or video. The girl entering the contest must have a significant part in producing and partaking in the film or video.
- The film or video entry must list the title and the girl entering the contest name.
- The girl entering the contest must still submit an official online application at www.zoesdolls.com and email a link to the video to info@zoesdolls.com by the stated deadline.
- Video entries should be uploaded to YouTube and the YouTube link should be submitted in the body of the email that is to info@zoesdolls.com.

Rules of Eligibility

- Must be a girl between the ages of 6-18.
- Must be a girl who resides in the State of Florida.
- Must believe that your image is beautiful and important.
- Must submit by the stated deadline.
- Must be able to attend the culminating banquet in May 2018, if winning entry is selected.

Judging & Selection Process

- Entries will be broken up into two age groups. There will be the 6-11 year old group and the 12-18 year old group.
- A first, second and third place winner will be selected in each group.
- All entries will be judged by the Zoe's Dolls staff and community stakeholders.
- Selected winners will honored at the banquet.
- Each girl that enters will be provided with two tickets to the banquet.
